OLD BUSINESS

1. Discussion and possible action on strategic planning workshop.

The Board was provided with links/copies of the strategic plans for MCC and AWC. Board Chair LeFebvre also provided a handout that listed the Mission Statement and the Philosophy and Educational Commitments that were established 10 years ago. The handout also provided topics to be used for brainstorming. Each Board Member was asked to bring their goals to the workshop.

Some discussion centered around the need for developing measurements and tasks to see if the goals that are established are being reached. While other discussion questioned the point of the strategic plan. Is the plan to determine measures or it is to determine where we want to be five years and creating the culture of WAVE?

Also discussed were establishment of additional central campus programs, senior transition programs, investment in human capital, increasing partner district capacity and using the plan to drive budget decisions.

The Board gave Superintendent West direction to create an administrative subcommittee to work on goals and bring back to future workshops/meetings. The Board agreed that it will continue having this on the monthly agenda knowing this is a long term process.

NEW BUSINESS

2. Discussion of WAVE budget with District Governing Board. The Board may vote to discuss personnel matters associated with the budget in executive session pursuant to A.R.S. § 38-431.03 (A)(1).

Superintendent West presented the Board with information on salaries and benefits for employees for 2018-2019 school year. This included an additional stipend for the program director for AzEDS reporting duties as well as a proposal for support at the Central Campus. Also discussed were ways to generate more interest from eligible substitute teacher candidates.

The Superintendent also proposed providing some targeted funding to our partner districts to reduce the District's carryover amount.

Other discussion included development of policies/procedures for empowerment scholarships recipients and the handling of out of state tuition for students participating in concurrent enrollment.

3. Future agenda items.

Out of state tuition for DACA students, empowerment scholarships tuition rate, substitute teachers, and targeted funding.

4. Motion to adjourn.
